☞ Over the past two weeks, I called the first ADSPB meeting where Chris Mundry, Executive Director of Knight-Thon, was elected to serve as my Vice Chair. We also held introductory meetings with Rick Falcon, Director of the Student Union, and Terry Mohajir from UCF Athletics. In addition, we met with Knight-Thon to explore ways Student Government can support their efforts to expand campus participation. I was out this past weekend and have been catching up on emails since returning yesterday. Lastly, I want to wish the best of luck to everyone going through confirmations tonight. We are nearing the end of the first wave of confirmations, so be proud of everything you have accomplished so far.

☞ Good evening, Senate. I was out of town last week but am back and running. This past Friday, I had the unexpected honor of valeting Congressman Maxwell Frost's car. Definitely not how I thought I'd meet a member of Congress. Two weeks ago, I had a great meeting with Pro Tempore Hameed where we discussed how we can work together more closely this year. I've also noticed that reversions tend to be significantly higher in the fourth quarter of the fiscal year 2024–2025. This could be an area worth exploring for potential improvements in reducing unspent funds. I've also been busy preparing my presentation for the Executive Retreat, focusing on ensuring every Cabinet member understands OPS guidelines, how to properly fill out ERFs, and general fiscal knowledge. I'm also making sure all Cabinet members complete their financial training by July 3rd. I sent Speaker Courts the updated OPS guidelines for the next three months, and all Executive Cabinet members will have them signed by the end of this weekend. Looking ahead, the new fiscal year begins next week, which means our balances will reset. CRT and FAO have already been working hard, and the A&SF Business Office will begin processing allocations soon.

☞ **Attorney General's Report (Jorge Altuna, sga_ag@ucf.edu)**

☞ Good evening, Senators, I hope you all are having a great week. I've been working on a number of initiatives since we last met. First, I finalized and distributed the parliamentary procedure packets to the Senate President and Senate Pro Tempore. These materials are designed to serve as working references for all senators, and I welcome any feedback as I would love to work with you on these packets, and if you also notice any errors or anything that should be added don't hesitate to reach out to me. I also prepared a comprehensive Sunshine Law and Ethics compliance training for Cabinet, which I will be delivering to fulfill our statutory requirements. I am also very happy to announce that all Senate rules now reflect all changes made since October 2024. Fortunately, I have also met with Chair Gaudio and Vice Chair Trejo Hernandez to go over statutory revisions and Senate Rules. Following those discussions, I submitted Statutes, Senate Rules, and my Opinions for upload through nQueue. Webmasters have projected a publication date of July 8th. I've issued three Attorney General Opinions since our last session that I would like to report to you:

☐ Opinion 57-01: It is the opinion of the Office of the Attorney General that if the Supervisor of Elections, after being elected by the Commission, does not meet the experience requirement, the Senate must waive that requirement in a $\frac{2}{3}$ vote before the oath of office is administered.

☐ Opinion 57-02: It is the opinion of the Office of the Attorney General that Student Government may not use executive session except under very narrow exemptions defined by Federal Law, Florida's Sunshine Law and Title XII. All other deliberations must remain public, unless an exemption applies.

☐ Opinion 57-03: It is the opinion of the Office of the Attorney General that non-elected individuals, such as the Supervisor of Elections, may sit on and vote in legislative committees, but only under very strict circumstances

explicitly authorized in Statutes and Senate Rules.

€ Athletics Coordinator (Dwayne Jones, sga_athletics@ucf.edu)

- Good evening, Senate, Since I have been confirmed in my position, I have gotten the chance to meet all of the contacts and university officials I will be working with this year. In my meetings with directors from the RWC, we discussed how we would like to better market all of the opportunities the RWC provides. I also met the Sports Club council and received their approval for my ball on the mall initiative. In my meeting with Rick Falco and Matt Adams, two directors from the student union, we discussed plans for a possible fall pep rally and upcoming events. With Matt who oversees tailgating on memory mall, I also discussed opportunities for Sports clubs to reserve tailgating spots together. Finally, I met our incredible athletics brand directors and alongside President Blanco and Vice President Benitez we held a meeting with our Athletic Director, Terry Mohajir. Through these conversations I introduced frost warning and discussed revamping the student section RSO reservations and beginning our Athletics rewards system.

- Good evening everyone, I hope everyone's week has been going well so far! First off, thank you all so much for confirming me as your Diversity, Equity, and Inclusion Coordinator. I'm really excited to get started and share some of the things that I've been working on. Since being confirmed, I met with Senator Teodorescu to talk about an initiative she had that was similar to one of my initiatives, and I'm super excited to see where that goes! I've reached out to the CAPS Director, the UCF Art Gallery Director, Dr. Muniz (HSI Director), and the SAS Director to explore ways we can collaborate and learn more about the projects they've been working on. I'm also really looking forward to seeing who the new caucus chairs are and getting a chance to meet with them soon. I'm really excited to hear what they've got planned for this year and figure out how our ideas can come together.

€ Safety and Transportation Coordinator (Emely Lopez, sgatransportation@ucf.edu)

- Good evening, Senators! I want to thank you all for appointing me to the position of Safety and Transportation Coordinator on May 29th. During my initial month, I have gotten the chance to set up and attend introductory meetings with numerous contacts that will be beneficial for me to collaborate with to carry out my initiatives. I was able to meet with the Administrative Coordinator of UCFPD Benita Harrison, the Director of Parking and Transportation Services Louann Huynh, and Law Enforcement Officer Kavaja from the police department in the Student Union. I have also gotten the opportunity to meet with the Senate SBA Chair Teodorescu regarding how we want to gather data on students' safety and transportation concerns and how we would like to act upon them. Following these introductory meetings, I got to get a start on a couple of my initiatives such as inquiries about student safety keychains, and planning the logistics of a tabling event that allows students to build their own hurricane prep kits with some items provided by Student Government to get them started.

€ Digital Media Coordinator (Gaby Parra, sgdigital@ucf.edu)

- Good evening, Senators, I hope everyone is having a good week! Over the past two weeks, I have been working closely with the Director of Communications to develop ideas on how we can enhance our communication efforts with the student body. In terms of analytics, our recent post regarding CRT and FAO forms has received approximately 21,000 views. Of those, 52% came from followers, while 48% were from non-followers. This data shows strong outreach but also highlights an opportunity we're now looking into strategies to convert more of those non followers into engaged followers. Our Juneteenth post also performed well, generating a total of 510 interactions, which we're very pleased with. Additionally, I met with a representative from Rosen campus last week and am scheduled to meet with Downtown campus next week to discuss an event called Knight Shot which is an initiative that offers students free professional headshots. We are working to expand this event to all auxiliary campuses, and I'll share more information as we get closer to the fall semester. Lastly, Student Involvement has reached out to request a video from all agencies for the Knighting event taking place during the first week of the fall semester. That will be one of my priorities that I will be working on for next week. Thank you all for your time!

- Good evening Senate, I hope you all have had a wonderful Summer semester so far, and that things are well for everyone. This month I have begun reaching out to members of UCF staff in various sectors, including Arboretum and Sustainability Initiatives, to begin preparations for weekly invasive plant removal shifts open to the student body. I am also in motion to collaborate with ASI on new programs hosted through the Arboretum Park including a wellness program called NatureRX. I have also been in contact with Knights on the Mall to continue the Sustainable Knights trash collection initiative for the upcoming fall tailgate season, and members of EHS to work out the logistics for the placements of E-Waste bins. Finally, space in the chamber has been reserved for three Green Assembly's this fall, which I hope to be resources for environmentally oriented researchers to network and share their findings, as well as local pillars in conservation getting to discuss the incredible work they do in an open forum. Please note that any amendments you make to the fiscal bill will be seen in debate, and if you are altering the costs on any line, make sure that you update all the relevant total costs. Lastly, we decided a few weeks ago that our funding cap for this session will be \$21,840.00, which is why both halves of the bill state this numbers. The total cost is higher than both halves because we cannot exceed our funding cap for each half of the bill, even though we know they will have to contribute more than stated.
