This meeting was not posted on the calendar or publicly announced prior to it happening, so I wanted to look more into it. This meeting was between branches regarding a policy that will have an impact on what is going in front of this public body. I believe AG Opinion 57-02 concurs that this type of meeting is a public meeting and falls under Title XII, so I wanted to bring this in front of the committee for deliberation.
 - ii. Matthews: I have a question, who took the minutes for the meeting?
 - 1. Chair Gaudio: AG Altuna
 - iii. Matthews: A question for the AG, in the minutes, were you guys planning on having another meeting?

That can be argued that discussion between us is a meeting. The non-compliance does more harm than good. It raises the question of what is considered a SG meeting.

- xiv. Pro Temp Rep: I agree with the previous two senators, having to differentiate between what is a discussion and a meeting is hard. You can argue that a discussion between two SG agents is a meeting. I don't think that these non-compliances are necessary.
