 - The funds saved by those changes essentially cancel out with the bigger fiscal bill (\$8,000 more than last year from the same RSO), meaning we're allocating about 11% faster than last year
 - Also note that we've already allocated \$44,111.07 from Q2, which is 22.9% of what is now a Q2 budget of \$192,482.34.
