Congratulations to Chair Rickett and Vice Chair Kaufman on a strong start. I also had a great and productive conversation with Supervisor of Elections Presley and Assistant Supervisor Collazo as we started preparing for a successful year ahead. I'm also excited to share that I'll be collaborating with Pro Temp Hameed and the Senate fiscal leadership to assist in the upcoming informational fiscal sessions taking place in early September.

☞ **Attorney General's Report (Jorge Altuna, sga_ag@ucf.edu)**

☞ Hey everyone, hope you are all doing well, it was a great time at the SG Family Picnic! Just a few updates from me this week: I'll be meeting next week with the Director of HSI to talk about translating the SG Statutes into Spanish. I'm really excited about this initiative I've been working closely with Pro Tempore Hameed. I also finalized my revisions for AG Opinions 57-02, 57-04, and 57-05. Huge shoutout to Chair Gaudio and Senator Lipner for their thoughtful feedback and collaboration throughout the process. Here's a quick breakdown of each:

- ☐ **Opinion 57-02:** This one clarifies how Florida's Sunshine Law applies to Student Government. After getting input from Chair Gaudio and Senator Lipner, I added a section that breaks down which bodies are bound by Sunshine versus those that are only subject to internal transparency standards under Title XII. I also emphasized that even when the law doesn't *technically* require it, SG should still operate in the spirit of open government whenever possible.
- ☐ **Opinion 57-04:** Clarifies that an accused candidate in a Student Government election violation hearing does not have the right to reschedule the hearing solely because the Judicial Advisor or Attorney General is unavailable. While the statutes guarantee the accused the right to seek assistance from these advisors, they do not require their presence for a hearing to proceed. The authority to schedule hearings rests with the Supervisor of Elections and the Election Commission, who are strongly encouraged, but not obligated, to accommodate based on the availability of the accused.
- ☐ **Opinion 57-05:** This covers what happens when the Supervisor of Elections gives a candidate incorrect information. Candidates are still responsible for knowing and following SG law, but if they relied on that misinformation in good faith, they could bring it to the Election Commission, and the Commission can take that into account when deciding whether a violation occurred.

- Lovely Legislators! I hope you all had a great summer, and are ready for the Fall semester that will be starting soon! I can tell you all with confidence that the Division of Communications and Outreach is off to a great start! Before I get into the nitty gritty of everything, I want to give a special shoutout to my mom! She's sitting in the audience section. She is so impressed with our student government, she was watching my confirmation and appreciated the level of depth and knowledge of the questions you all had for the different candidates, so kudos to all of you!
- Going off of what digital media coordinator PARRA mentioned, the knight shot events is open to all students who want to get professional headshots done. The Photo Booth in the student union is getting moved to the library but we don't know for how long it'll be unavailable, that's why we're having the knight shot event. SG headshot day is in the works but just know that'll be something separate from knight shot
- Last time I spoke with you all I mentioned a poster on the SG office wall I wanted to turn into a collage of sorts, this is what it looks like right now... Thank you to everyone who's participated, if you haven't yet, I encourage you to add a photo, sticker, or small note and help us fill it up!
- Another thing we mentioned at the last session was the tabling sessions. That was one of my initiatives this year — to have weekly 2 hour tabling sessions alternating between branches, caucuses and the election commission. I have the dates for everyone so feel free to reach out to me if you want to know in advance all of the dates that your designated SG grouping will be responsible for attending, if not I'll be sending out reminders on a monthly basis .
- Before the month ends, I will be posting open seats to let our students know of the available positions. I probably will put something on the Instagram just to get eyes on it, but know that the details will live on the LinkedIn, which is something new that we're trying out. I'm super hopeful that posting our openings through that platform will provide a good way for students to stay in the know of how they can get involved.
- As for our instagram itself, our most recent video went live just two days ago, reaching around 7 thousand accounts. This isn't bad necessarily, but just so you understand, our engagement through viewership for this reel is at 31% of all accounts reached, but we could be doing just a bit better ... for reference our typical reel has a 34% viewership engagement rate. Now we can't control who will sit and watch our videos to their entirety, but something that will help us land at the top of more people's pages is by engaging with our content. If more people are liking, sharing and commenting on our content the engagement will help boost our messaging. So I encourage everyone to participate online if you feel comfortable doing so, and this will help us hit our goal metrics.
- Ok. Who here is excited for sgls? We are just getting ready to start posting informational content inviting students to join. We have some graphics ready to circulate, and we are in the works of setting up a video shoot. If anyone is comfortable participating, we are looking for 4 SG agents outside of SGLC coordinators to be a part of our SGLC promotional video. Just know I am looking for some new faces for our instagram, so if I haven't posted anything with you in it, and you want to participate, let your comms liaison know, that would be ELA Reed, External Assistant Chief Justice Villadarez, or your Election Commission leadership.
- Speaking of election commission, I had the pleasure of attending an introductory meeting with Supervisor of Elections Presley and Assistant Supervisor of Elections Collazo Borges to lay out the groundwork on how our division can best support the commission and I am super excited for what the future holds as they have some great plans ahead.
- This leaves our Judicial Branch, which I will be having an intro meeting with, early next week, and once the caucus leadership chair is elected, I will be meeting with them as well to get a holistic view of what their needs are in terms of communications and outreach and how we can help them achieve their goals.
