 - ii. Collazo: During IRC, argument was Sunshine Law as basis. We hold other branches in check, so we should be transparent. Sunshine law doesn't necessarily apply to us.
 - iii. Chief Justice Silva: What scope?
 - iv. Collazo: Cabinet doesn't release minutes, but Senate does. Florida law doesn't require us.
 - v. Ray: It is almost up to us to determine the scope.
 - vi. Rivera: Not much to hide, just keeping our executive session private.
 - vii. Chief Justice Silva: We aren't fully formal, and that doesn't necessarily work for us. It will be a transition, but we should make the decision as a Council. First steps? What are the possible things that we don't want up.
 - viii. Advisor Brodie: Technically, SG is not a true government and we are not inherently bound to the Sunshine Law. But statutes say that we are aligned with the Sunshine Law, and rewording the statutes that transparency requirements remain the same but not bound by Sunshine Law. Anything in statutes remain and we must comply because we agree to them. Minutes should be posted and meeting announcements should be on the website.
