 - ii. Strike and modify are parliamentary procedure – Robert's Rules
 - iii.
- 2. Rule 1.02: "Appeal":
 - a. Remove "legality of" and "corporate", instead "review an action or decision of student government or affiliated entities"
 - i. Relevant to judicial review
 - ii. Do we work with corporate entities
 - iii. We don't deal beyond the student scope
 - iv. Affiliated may reflect actual procedures better
 - v. Leave in legality for appeals sake – we are bound by laws
 - vi. Nerro: taking it out doesn't constrict us
