- g. New Business
 - a. Election hearings
 - i. The goal of this is to understand the situation, the violation, what was violated, and the sanction. This process will help us develop the ERP and potentially support the updates to title VI.

 - ii. Chair McCarthy explains we will be going through all the violation hearings from the previous year to get an understanding of how they work. If you are looking to pull up with the file, direct yourself to the files on teams since they are all linked under our teams' channel
 - iii. Five- minute timer to read the files/ affidavits
 - iv. Reviewing violation hearing- candidates advertising that they were running for the election before the candidate timeline. It violates how active campaigning before the period is a huge violation
 - v. Commissioner Phillips: it was hard to stay neutral because of political views and professionalism. You must stay professional to remain non-bias, even if someone is against your own political party it is not a crime or a violation.
 - vi. Attorney General: Because of Lester, you cannot be affiliated with a political party, and hopefully it will address the issue as well or at least minimize it
 - vii. Chair McCarthy: pointing out the clarification on the linked in post since they were not aware of Lester running. In the insistence that someone is being promoted by a third party, or friend and they were not aware. There is a lot of grey area, so we want to draw a law
 - viii. Commissioner Phillips: a lot a candidates didnt read the rules but you cant excuse negligence either.
 - ix. Chair McCarthy: the rest is just the tickets and the evidence
 - x. Commissioner Phillps: The further you go the worse they get. People had a lot of personal issues before but turned it into something else. All the evidence is like a personal anecdote. A lot of candidates like to bring in external issues in order distract from what actually needs to be discussed
 - xi. Chair McCarthy: The LinkedIn post was approved for a sanction. Senator Autmn Johnson also heard him explain that he was running for senate in November which is before the active campaigning period

b. Moving on to 2.28

- i. Chair McCarthy: Two affidavits against Lester
- ii. Commissioner Phillips: Lester posted and made an Instagram page, back in December the post went viral. Luke Brown's point was negligence is not an excuse to violate the statues
- iii. Commissioner McCarthy: 2nd affidavit- failure to submit the expense reports. This was more logistical than problematic
- iv. Commissioner Calloway: His first post was on the 12th of November??
- v. Commissioner Phillips: He got 200 votes in total, nobody got a majority
- vi. Chair McCarthy: We are now taking a look at the expense report. Both of the submissions were late and there was also a missing physical statement. He just forgot to do it, not any additional sanctions
- vii. Chair McCarthy: moving on to the next violation involving Garett and corsac, using a personal Instagram account trying to see if there was active campaigning. A Reddit post on the 16th of February and then handing out flyers.
- viii. Commissioner Phillips: this was a friend thing; the john dude was advertising for them. They were in model UN together and the John man really liked what Garrett was running on, so he started running for him or campaigning for him. John was mad because the commission had "failed" him. No violation occurred here
- ix. Chair McCarthy: We need to define the line in third parties. And that all I have for us to go over. Any questions or concerns
- x. Commissioner Phillips: How much of title 6 are we rehauling
- xi. Non-Committee Member: They are not changing the content but changing it around so candidates can understand it easier. Eventually, they want to go through each chapter to make sure it is clear, and the language is concise.
