8. New Business-

a. Fiscal Appeal Form Changes

i. Introduction

1. Delete prior introduction page, replace with new one to mirror approved Parking Appeals introduction – pending council approval
 - a. Add “deemed with merit”

ii. Eligibility

1. Ask if sanctioned, and when sanction expires
2. Need to have conversation, assistance from IRC, whether we are able to appeal decisions or just sanctions and fine tune form depending on response
 - a. Grady: Reference statutes – check JRP. If not in JRP, we are unable to make a decision.
 - b. Nerro: Title V – 505.5
 - c. Porlles: “Including but not limited to, funding and probation decision for RSO’s...”
 - d. Grady: The “but not limited to” makes service seem not just based in sanctions

iii. Student Appellant Information

1. Change “Knightsmail” to “UCF email”
2. Add “(e.g. ab123456@ucf.edu)” and mimic parking form to state no personal emails will be accepted

iv. Written Appeal

1. CJ Pazera: Would like to add selection options for grounds for appeal like parking appeal forms - will await council approval
 - a. Grady: Do we want to include section to cite relevant statutes?
 - b. CJ Pazera: No, can be added in written appeal sections if they wish
 - c. Nerro: can make non-required question, so can add if needed.
 - d. Hoffner: in favor of drop-down, add “procedural error”
 - e. Porlles: change “senate error” to “procedural” rather than adding additional option
2. Delete “when was the appealed decision issued?”
